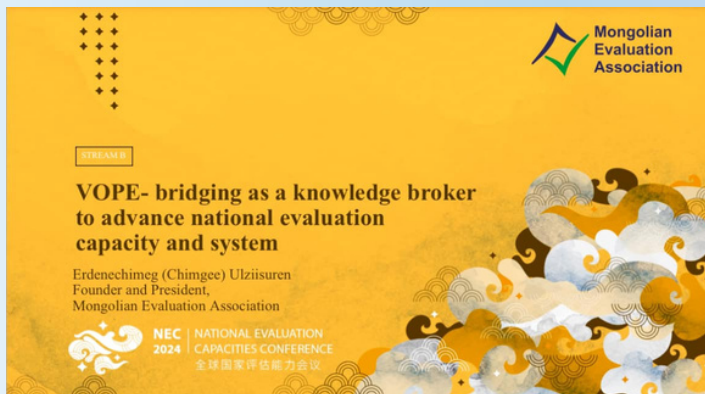
## MEA PARTICIPATED IN UNDP NATIONAL EVALUATION CONFERENCE IN BEIJING

The 2024 National Evaluation Capacities Conference, 8th in the series of conferences, was co-hosted by the China International Development Cooperation Agency (CIDCA) from 14 to 18 October 2024 in Yanqing District, Beijing, China. The main theme of the conference was “Responsive Evaluation: For Government, For Inclusion, For the Future.” The theme brought light to the importance of sharing experiences and lessons in strengthening national evaluation systems and their role in achieving the SDGs among others. This year’s conference was organized around three intersections: National Evaluation Systems; Inclusive Evaluation Systems; and Future-driven Systems and Approaches.

500 delegates from all over the world representing Government, Parliament, int’l organizations, VOPEs and academia rigorously discussed the inclusion of evaluation these 3 days in Beijing, and as a result Beijing Action Plan for Responsive Evaluation Systems for 2023 was drafted. and shared with the participants for comments.



Ms. Erdenechimeg Ulziisuren, founder and president of the Mongolian Evaluation Association, represented the organization at the National Evaluation Capacities Conference in Beijing. She delivered a presentation on “VOPE- bridging as a knowledge broker to advance national evaluation capacity and system.”



This year from Mongolia, a newly appointed Parliament Member Ms. Mandkhai Mendbayar, Ms. Elbegzaya Tserenbaljir, Officer at Evaluation & Monitoring Department of Secretariat at Parliament, Ms. Khurelmaa Dashdorj, Planning, M&E Officer, UNICEF Mongolia also participated the NEC Conference.





## MEA MEMBERS ATTENDED AMERICAN EVALUATION ASSOCIATION'S ANNUAL CONFERENCE

MEA members took participated in the AEA Annual Conference, held in Portland, Oregon, with the theme "Amplifying and Empowering Voices." With over 37 years of history, AEA continues to be a vital resource for MEA as it works toward institutionalizing evaluation in Mongolia. Despite MEA being only three years old, it has already received tremendous support from AEA, its past Presidents, the Washington Evaluators, American University, and several leading figures in the evaluation field.

Her third attendance at the conference, Oyuna Jukov shared her experience:

Over four days, she not only participated for her own growth but also represented the Mongolian Evaluation Association (MEA) in strengthening connections within the global evaluation community. She was proud to further this networking at the conference and celebrate MEA member Tseveengerel Amgalan, who, as a former government officer in evaluation and current MSc student in Data Science at Bentley University, presented her poster on "Challenges and Strategies in Implementing Results-Based Management in Mongolia." Tseveengerel was awarded an International Travel Grant by AEA, and she looks forward to reading the completed research soon.

The conference emphasized the importance of inclusivity in evaluations, highlighting voices from Indigenous groups, youth, and marginalized communities. A notable presentation by Global Affairs Canada introduced the "Localization Analysis Framework", a tool to assess programs' alignment with locally-led development and local ownership.



The conference featured a No-Code AI Hackathon, where participants explored how AI tools such as chatbots and platforms like GPTs could enhance evaluation practices, sparking creativity and showing the potential for AI to reduce the digital divide.

The MERL Tech Initiative led a session on the use of AI tools like GenIA, NLP, and LLMs to transform SBC programming, focusing on areas such as sexual health and vaccine uptake. These AI tools are improving monitoring and evaluation but face challenges around ethics and data quality.

Dr. Reinhard Stockmann's research on the global institutionalization of evaluation resonated with MEA's goals. His findings will be shared at the upcoming APEA webinar, moderated by Tseveengerel Amgalan.

Story Slam: Participants shared impactful stories about how new evidence shifted their perspectives and careers. The facilitator, Anne-Louise Sterry, expressed interest in conducting a similar session with MEA in the future.

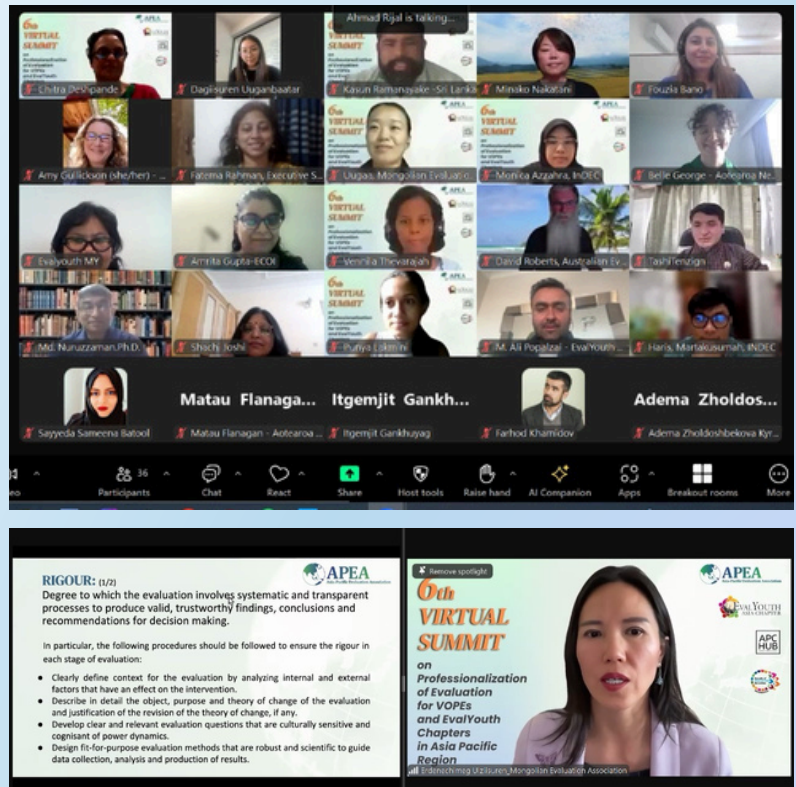


## 6th Virtual Summit on Professionalization of Evaluation

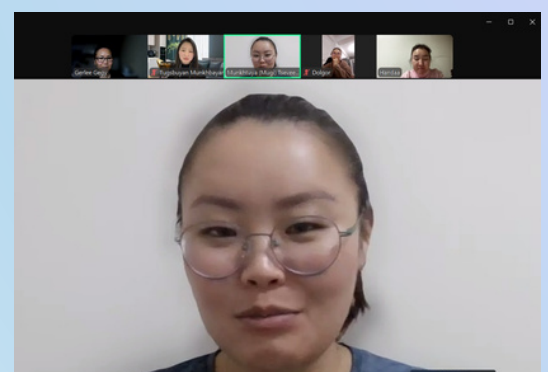

## MEA partnership with Lanzhou University



We are pleased to announce the Memorandum of Understanding between Center for Evidence-Based Social Science at Lanzhou University and Mongolian Evaluation Association will be signed at in China on November 9, 2024. Both parties came to this exciting moment cumulatively expanding mutual partnership starting from initial connection during the 2nd Summer Evaluation Bootcamp in Mongolia in July, and further discussion at UNDP National Evaluation Capacity Conference in Beijing in October this year. The purpose of the MOU is to further strengthen academic exchanges, talent training, and collaborative research between the two institutions, and to jointly promote the research, application, and dissemination of evaluation for evaluators of Mongolia and China.

## MEMBER SPOTLIGHT



**Galbadrakh Erdenetsogt**  
**MEA Member, YEE**

Galbadrakh Erdenetsogt is a current student at the Chinese University of Hong Kong. He was first introduced to the field of evaluation through The Young Emerging Evaluation (YEE) Internship Program which profoundly impacted his career, offering him the chance to work with inspiring professionals and develop practical skills essential to the evaluation field. Through a six-month internship organized by the Mongolian Evaluation Association and YOUTHinc, he gained firsthand experience with organizations like UNESCO and ILO, learning to assess project efficiency and the role of evaluations in effective decision-making. His mentors guided him in mastering tools like necessary, equipping him with skills for analyzing and reporting critical data.

A pivotal moment during the internship was his involvement with the manifest-signing-and-standard-adoption team, which introduced him to international evaluation standards. Recognizing the lack of youth-driven evaluation initiatives in Mongolia, he became determined to bridge this gap. Collaborating with his team, he engaged decision-makers and advocated for youth participation in evaluation processes, leading to the successful adoption of these standards in various Mongolian institutions. This experience reinforced his commitment to fostering a sustainable, inclusive evaluation culture, envisioning youth as key contributors to development and societal impact in Mongolia. He was part of team Progresso in the World Evaluation Case Competition, representing Mongolia as the Asian Champion in 2023, which helped him understand the practical side of evaluation. As an active member and YEE of MEA, he also contributed greatly in organizing the Youth in Evaluation Week champion event: Good practices by VOPEs and youth organisations as part of the production team, as well as the 2nd Summer Evaluation Bootcamp, as part of the organization team.
